



## **President's Report**

As President of ERT Inc, I would like to report tonight on the 13th year of activities of Eastern Region Tennis Inc. The 2006/07 year has again proved a success on and off the court, even after allowing for the issues of the recent water restrictions imposed by the State Government, although some people think that the Government were a little slow in reacting when looking at the potential short and long term effects this might have on the Tennis Clubs with the red porous - entous-cas tennis courts.

Financially we have again improved our overall financial position, even after we have had a complete review of our various income and expenditure streams, some of which resulted in a bigger subsidy being provided by ERT in a number of areas in 2006/07.

ERT has again recorded a profit, which is great news for the review process, and we should compliment the people on the various ERT Committees who have delivered all their services within ERT budget/guidelines. ERT is in a very sound financial position with a very bright future. The profit for 2006/07 was possibly in excess of our initial expectations, but is a real positive for the administration of ERT. The Treasurer can elaborate on this later in his report and although I have mentioned in previous reports, we would not be in the position we are, without this fabulous contribution by our Treasurer -Robert Jamieson - thanks again for a 140% contribution in your reporting and comprehensive reports. This result has been achieved with a much more aligned assessment of our income and expenditure in all areas, where we now know the costs of providing the individual services that we do. Thanks Robert for a great job, and lets say a bloody good job well done and I would hope there are more



people in the E.R.T. community and/or member clubs who could assist ERT. with your drive and enthusiasm. Lets see some new volunteers come forward tonight. We can only hope this occurs, as we desperately need an injection of some new blood, and unless this happens, we may not have ERT, and then the Clubs and the individuals the losers. Lets hope this does not eventuate, although it is a critical time/ position that needs attention/addressing now, not later on.

I would like to thank all the various committee's within E.R.T. for focusing on the personal and financial situation that we face from year to year. I trust that all the Clubs and their members have yet again enjoyed the success's of what I still feel is the best administered Association in Victoria, and which is one of the largest in Victoria. Congratulations to all those who have enjoyed individual, team, personal and/or combined successes in the last twelve months. Congratulations to all those who have won a Grand Final in the last 12 months - well done.

Congratulations to all the winners of the Winter 2006 and Summer 2006/07 Summer competitions and to everyone else who participated in these Senior and Junior competitions. Without your

individual and continued participation, we would not see the successes that we are all enjoying. I wish everyone continued success in the remainder of the Winter 2007 season. Good luck to all those who will be playing in the finals, and those playing in the forthcoming Summer 2007/08.

I would also like to again reiterate from last year's report, that I am still very concerned at the declining number of clubs/teams participating in ERT. This still causes the ERT. committees a great deal of concern, and is an on-going major problem which needs to be addressed. The latest figures are provided at the end of this report.

The member Clubs of ERT, will need to address the issue of the "Working with Children " Act which has been passed by the Victorian Government. We will all need to address this issue in the short-term and have these requirements met by all Clubs in the next 1-2 years. We will require all Clubs to advise ERT. in writing that their Clubs accept this position. I would also like to stress and re-iterate that when a Club is considering a person within that Club that needs to provide a Police Check, that the Clubs must sight the ORIGINAL of this Police Check, and that this position is nonnegotiable - no photocopies, only an " ORIGINAL".

## **Succession Planning.**

If you look at my report from last year, I made some comments about succession planning, and trying to get some new volunteers to join ERT. This has met with an almost zero reaction, which is not a good sign. The current personnel at ERT have a wealth of experience, which would be made a little easier, if this could be progressively passed on to some new members, before they retire or move on, and we need to share this expertise, rather than lose it.

We - ERT. are still in desperate need of new people/volunteers -otherwise ERT will not be in a position to operate and provide the "grass roots tennis" with the quality of services which they want. Please, can we be honest and open here, and realise what I am saying. We need some new people to get involved, with or without experience. Can we please jump on board, and contribute and give more support to the role within ERT which is going to need new office-bearers within the next 12-24 months. As I have indicated in previous reports, my use-by date is very near, and I would like to retire in peace and pass on my role to a new person next year, provided I nominate and are reelected in September 2007. I am saying that this is now more seriously approaching my last year, so that the members of ERT will now have to more seriously take " on board " my comments that the position is such that a new President is now a reality and not a possibility. Please treat this is a serious issue.

I would like to extend a special recognition to all the personnel involved within ERT and say what a great team job they have all done, sometimes under duress. Thanks again "team" for a great job, well done yet again and lets hope that we can yet again improve in our level of service that we provide to the many member clubs.

Good luck to everyone for 2007/08 season and best wishes to all ERT Executive and their families and all other ERT Members/ Committee's and their families for 2007 Christmas and the 2007 New Year festivities.

It is my pleasure to present the Competition sub-committee annual report for 2006/07.

It has been a busy year with stage 3 water restrictions coming into force, sets and rubbers were reduced to 6 games sets and rubber to best of two, we were very grateful to the clubs for the immediate response.

At the time of going to print we are still in stage 3A water restrictions with any new restrictions or variations coming into force being put on hold until the end of September 2007, we hope the status quo is maintained, not only for the clubs/players but our coaches as it is their livelihood.

It has been recommended that Eastern Region revert back to 8 game sets for the summer season, at this stage this is what will happen.

Winter season, continued with 6 game sets, but with the damp weather could [in hindsight] we could have gone back to 8 game sets, no complaints clubs just got on with the job of running matches. Finals are upon us good luck to all participating and congratulations to all the winners, commiserations to runners up.

Summer 2007/08, a new category has been introduced for senior Saturday **Singles/Doubles,** 4 players (any combination of men & women) play one singles rubber [best of two, if set all then match decider] and two 6 games doubles. I am pleased to say there will be four sections, so thank you for the support.

Over the past season, a number of letters to the committee have outlined behaviour of both players/parents, I am at present trying to organise an umpire/referee to



attend the next convenors meeting to outline rules for 'non-umpired' matches and what supervisors can/cannot do when dealing with players/parents.

I must thank our computer guru Bruce Leister, who is on longer on the Eastern Region committee, but he is certainly not lost to us with his tireless work behind the scenes, he gave a presentation at the most recent convenors meeting – updating club information via the web, next on the list – yes!! Wait for it on-line team entering.

Many thanks to our hard working record secretaries Roma Shipp (Senior) and Cynthia McKenzie (Junior) along with Steven Morgan and Hugh Hayes. Judith Dungey for back-up support.

# Tournament/Development Report

On behalf of the Tournament /Development Sub Committee I have pleasure in presenting the annual report of 2006/07

ERT Development Squads are now functioning well from a centralised location. Their focus continues to be ability based training groups. Thank you to Heatherdale Tennis Club and Wantirna Tennis Club for making their courts available.

In 2006 twenty teams represented ERT in the Victorian Junior Competition. Seven teams participated in the final series with the 10A Boys, 12A Boys and 14A Girls winning pennants.

This year has seen a name change to 'Junior Pennant' and the inclusion of doubles sets to the format. We have entered 2 mixed teams, 7 Girls and 12 Boys teams into this competition.

ERT junior teams have participated in 2 new challenges this year. The Daphne Fancutt Shield saw 12 juniors representing ERT in a round robin team event in January 2007. We finished in second place with Meghan McDonald receiving the 'Best Team Member Award'.

The inaugural Frank Sedgman Cup was held in October 2006 with 4 of our 11 and under junior players participating, followed by the 2007 Frank Sedgman Cup being played in August this year. The 2007 event saw the ERT team as the overall winners of the competition. A very commendable effort by these young juniors.

A team of twenty players travelled to Adelaide to represent ERT in the Pat Pearce Memorial Shield during Easter 2007. Head Coach, Dean Barclay conducted seven weeks of training



leading up to this event. They where rewarded by finishing 3<sup>rd</sup> in this event. An excellent individual result was achieved by Damian Wills who won the award for 15 & Under Boys Best Player.

A team of twelve juniors travelled to Traralgon to participate in the Inter Regional/Association Teams Challenge involving sixteen teams from country and metropolitan Victoria.

ERT Annual Points Tournament was held during the March school holidays. This tournament continues to remain successful despite the necessity to hire additional hard courts to cope with current water restrictions.

I would like to thank clubs for offering their courts and facilities for use by the association for trials, competition and training squads. I would also like to thank all the team managers and parents for their support throughout the year.

I would also like to thank my enthusiastic subcommittee and the Executive for their support this year.

## **Treasurer's Report**

## By Robert Jamieson

This financial year the association recorded a surplus of \$10,098 which was a decrease from a surplus of \$24,496 last year.

The main reasons for the change are as follows:

- 1. The decrease in **team entry fees** has now taken effect and fees income was down by \$2560 from this source.
- 2. We no longer charge a **trial fee** for Junior Pennant and that has reduced income by \$2000.
- 3. The **Easter Carnival** this year was held in Adelaide and net costs for this event were \$2363.
- 4. The surplus on the **ERT Junior Tournament** was \$3337, down from \$5476 last year largely due to increased cost for court hire and officials' fees.
- 5. Interest income was up by \$953.
- 6. Honoraria payments are up by \$1725.

Financially this was a good result and I would like to thank to the office-bearers and sub-committees who have made the changes required to bring this about.

During the year we purchased two new laser printers for \$689.

We do not propose any fee changes for 2007-8.

I think the change in the system of paying honoraria worked well, and we are not



proposing any further changes for this coming year.

ERT has large financial reserves and in the coming year we are spending some of our funds to create an association contacts database which should ease the workload on both club and ERT officials at the start of each season. You will have only to update changes rather than re-enter all the club data.

Another initiative is the President's Dinner, coming up on 14th September which I think will be a worthwhile use of ERT funds for the benefit of all clubs.

My thanks to Andrew Gibson, our auditor, for auditing our accounts again this year and for wading through the financial records I supplied him.

# The Eric Obst Perpetual Trophy

Named after the first Secretary of EMRLTA and awarded annually to the Premier Club within the Association. The Competition is decided along the following lines.



## 1. Eligibility

To be eligible for the trophy a club must have competed in ERT in at least two grades of both Seniors and Juniors in both Summer and Winter Seasons of the same year, i.e. at least 8 teams.

### 2. Premiership Points

At the end of the home and away matches the total number of points gained by a club in

every section is to be divided by the number of teams fielded by the club. The points and number of teams will be cumulative for the Summer and Winter seasons.

## 3. Weighted Points

Because it is felt that larger clubs have more difficulty in obtaining points to win this trophy for every 8 teams entered in the competition (Summer and Winter) 1.00 points are added to the total.

4. To be eligible for the trophy a club must have competed in ERT in at least two grades of both Seniors and Juniors in both Summer and Winter Seasons of the same year, i.e. at least 8 teams.

## 5. Championship to be decided on:

- 5.1 Total number of premiership points won by all teams of the club in EMRLTA during the 12 months.
- 5.2 If a tie after this, further points awarded:-
  - 4 points for a team finishing 1st after home/away rounds.
  - 3 points for a team finishing 2nd after home/away rounds.
  - 2 points for a team finishing 3rd after home/away rounds.
  - 1 point for a team finishing 4th after home/away rounds.
- 5.3 If still a tie the number of pennants won in the year would be worth 1 point per pennant.
